FEDERAL BENEFIT PAYMENTS Mandatory Electronic Payments for Federal Benefit Payments Starts March 1, 2013

The U.S. Department of Treasury is phasing out paper check payments and requiring federal benefit recipients to get their money electronically. What does this mean for you? If you currently receive Social Security, VA or other federal benefits by check, you will need to start receiving your money via the Direct Express® Debit MasterCard® (a prepaid debit card for federal benefits) or via Direct Deposit.

With direct deposit, your benefits will be automatically deposited into your CFCU account on time, every time. It's safe, secure and completely convenient. Even making the switch to direct deposit is simple. Just stop by your local Coconino FCU branch with your

CREDIT SCORES Tips To Strengthen Your Credit Score

Whether you're looking for ways to improve or to repair your credit score, it's important to note that strengthening your

credit takes time and patience. Fortunately, the hard work you put into bolstering your credit will reward you in many different aspects of your life, including whether or not you'll qualify for loans or credit cards and with what rate and terms.

Here are a few tips to help you get started:

- Get copies of your free credit report by visiting www.annualcreditreport.com, and review your report to verify the information is accurate.
- Pay your bills on time. If you have a hard time remembering to make payments by the due date, try setting up automatic payments from your CFCU account.
- Minimize your outstanding debt by paying down your balances.
- Apply for new credit accounts with caution. Applying for too many new accounts in a short timeframe may negatively affect your credit.
- Allow your credit accounts to age. Try not to close one credit account only to open another. The older your credit history, the better your score.
